Acknowledgment of Risk: The undersigned acknowledge(s) that activity related to livestock, rodeo, trail ride, and horsemanship events are dangerous activities and that participation in rodeo training activities and other rodeo related activities expose the participant to a substantial and serious risk of property damage, personal injury, and even death. Notwithstanding the risk involved, the undersigned expressly consent(s) to the participant assuming such risk.

2. **Release of Sponsors and Others:** The undersigned being fully aware that participating in the Northeast Oregon Christian Cowboys Rodeo Bible Camp and the activities related thereto, will expose participant to a substantial and even serious risk of property damage, personal injury or death hereby releases and forever discharges the Northeast Oregon Christian Cowboys, their respective officers, directors, agents, employees, successors and assigns, and anyone acting on their behalf, from any and all damages, costs, losses, claims, actions or causes of action of every kind and nature, whether past, present or future, arising out of or in any way connected with the participant's participation in or attendance at Rodeo Bible Camp.

- 1. The parent or legal guardian enrolling this child at camp certifies that the child is both physically and emotionally healthy; acknowledges that this application is accepted subject to complete examination by a physician.
- 2. The camp is not responsible for campers' equipment or personal belongings while in transit or at camp.
- 3. Gratuities, in any form, for staff members or camp personnel, are prohibited. Parents are expected to adhere to this important camp regulation.
- 4. No reduction, refund or allowance will be made for late arrival, dismissal, or withdrawal of a camper, for any reason.
- 5. We fully understand that the Camp reserves the right to dismiss, in its sole discretion, a camper whose condition, conduct, influence or behavior is deemed by the Camp unsatisfactory or detrimental to the best interest of the Camp or who violates the Camp Rules and Regulations. We acknowledge that the camp cannot replace the camper once the season has started, and that we will not be entitled to any refunds.

Due to space availability, there will be one horse per stall. One horse per camper.

Stall refunds will not be given out until the last campers have received their awards. Please plan your schedule accordingly.

It is the camper's responsibility to get the inspection and pick up the refund.

If the stall is not cleaned, or refund is not picked up the last day of camp, the money will go to Northeast Oregon Christian Cowboys.

Please Note: Horse must be suitable for your child's event. Suitable means **safe**, **dependable**, and **capable**. Your child's safety, and the safety of others, is our greatest concern.

What you need to bring to camp:

- Bedroll. Cot Optional, Small Tarp Optional (Sleeping quarters are in a barn on the floor. It can get pretty cold.)
- Personal care items (soap, towel, etc.)
 - Swimsuit for Locker room showers. Campers are bused to local school for showers.
 - Shower shoes (flip flops, sandals, etc.)
 - Clean clothes (including long-sleeved shirts and jeans for Rodeo)
 - No spaghetti straps, midriff showing, low-cut revealing tops, short shorts, or vulgar sayings/images. *If asked by a staff member to go change, please do so.*
- Western boots, hat, and/or helmet, & rain gear
- Bible and Notebook
- Saddle Horse & gear + Rodeo equipment (if you have any)
- Hay, feed, & water bucket, as needed

Please Note:

- Long-sleeved shirts, boots, jeans, and hat or helmet must be worn while competing in the arena. Not necessary during clinics
- Clearly mark all belongings with your name.
- No trailers are to be parked in tack area overnight. Parking provided.
- Only paid, signed up youth are allowed to stay overnight on rodeo grounds, due to insurance requirements.
- No dogs.
- NO PHONES: Leave your tablets and cell phones at home or turn them in at the office.
- Absolutely no drugs, alcohol, or tobacco.
- THE CAMP IS NOT RESPONSIBLE FOR LOST OR STOLEN ARTICLES!
- All campers are required to attend all scheduled activities.
- No one is allowed on grounds other than campers and staff during camp. All camping must be done off site.

Camp will end following the presentation of ALL awards on the last day of Rodeo Bible Camp. Campers will not be released, and stall fees will not be given out before the Awards Ceremony is completely over. Due to the increased number of campers, plan to stay a while and honor all of them!
